- 5. Billboards erected without Council approval ae subjected to a penalty and will be removed and stored at a daily cost.
- 6. Change of location of any billboard should be requested in writing and should only be done with Councils written consent.
- 7. It is the responsibility of the applicant for making necessary arrangements with the power suppliers in this case NORED.
- 8. It is the applicants responsibility if the billboard/sign become dilapidated, has fallen into disrepair or becomes dangerous or a nuisance, to remove the sign immediately.
